

#### **Financial Management**

- Prepares and submits the annual RHA budget to appropriate funding agencies.
- Oversees the preparation and submission of financial statements to regulatory agencies.
- Oversees monthly processing and posting to the General Ledger.
- Analyzes and prepares periodic cash flow projections to ensure adequate cash availability and maximize earnings.
- Processes and oversees annual and special audits, coordinating with outside agencies to resolve findings.
- Prepares and distributes financial statements to the RHA Board, funding agencies, and regulatory bodies.
- · Monitors and tracks grant funding.

#### **Operations Oversight**

- Supervises professional and clerical employees, including assigning and evaluating work, initiating discipline, and conducting performance appraisals.
- Oversees routine accounts payable, accounts receivable, and payroll processing.
- · Oversees RHA's insurance program and ensures adequate coverage.
- Oversees and maintains RHA's investments of surplus funds in accordance with guidelines.
- Monitors distribution and control over RHA's fixed assets.
- Coordinates finance-related data processing activities with MIS personnel.






